Burial fees with effect from 1st April 2026

Please note that the allocation of plots is at the discretion of the Parish Council

Fees payable in Part A apply where the person to be interred is, or immediately before death was, an inhabitant of Northill Parish. In all other cases the fees will be quadrupled. An exemption to this would be if the person had been an inhabitant of Northill Parish within 5 years of their death, subject to their removal from the Parish for the purpose of hospitalisation, nursing, or recuperative care or for the purpose of pursuing a course of further education. NPC will always consider cases in exceptional circumstances on a case-by-case basis.

Northill Parish Council recover the costs of interment for parishioners under the age of 18 years from the Children's Funeral Fund.

Fees payable in Part B apply where the person purchasing the grave is an inhabitant of Northill Parish. In all other cases the fees will be quadrupled. An exemption to this would be if the person had been an inhabitant of Northill Parish within 5 years, subject to their removal from the Parish for the purpose of hospitalisation, nursing, or recuperative care or for the purpose of pursuing a course of further education. NPC will always consider cases in exceptional circumstances on a case-by-case basis.

For each subsequent inscription the fee shall be 30.00
